

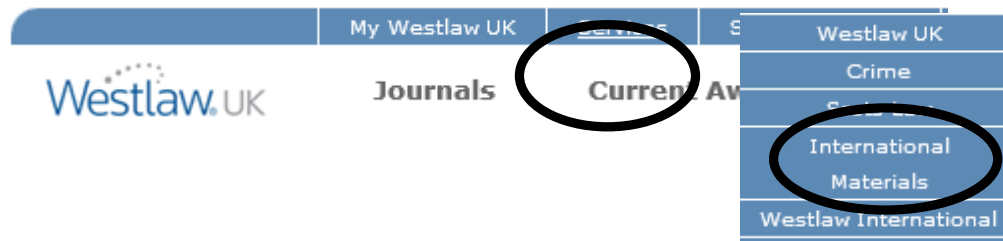

Getting started - Westlaw International – “Westlaw Next”

Is found by going to Westlaw and clicking on “Services”:



JOURNALS

The first screen searches journals from all jurisdictions *except* USA – please note that the “UK” search covers the same journals that you can search in Westlaw UK – so you won’t gain anything by searching both Westlaw and International materials for English publications.
